**Re: Notice of change of Ford – Kenya Party Officials**

We act for Ford- Kenya on whose instructions we write as hereunder.

On 4<sup>th</sup> June, 2020, you wrote to Hon. Dr. Simiyu Eseli notifying him of certain deficiencies in respect to documents lodged with you by the said Hon. It will therefore be appreciated if the documents could be forwarded to us by email and/or hardcopy by 8<sup>th</sup> June, 2020.

In the meantime and to avoid your office being misused by the individuals behind the intended unlawful alteration of the leadership of our client, please hold any action as desired in the documents submitted by Hon. Dr. Eseli pursuant in his letter of 31<sup>st</sup> May, 2020 or any other documents submitted to you thereafter.
